Prayer

- that God will use the new building to equip us for teaching God's word and welcoming our neighbours in the name of Jesus.

If you would like to commit to praying regularly for the building project, you can sign up for email prayer updates. These are usually sent out fortnightly, with additional updates when specific matters or urgent prayer needs arise. You won't get inundated with a ridiculous volume of emails! Do you shop online? If so, you can raise funds for the building project every time you buy something, with no effort and <u>at no additional cost to you</u>. Most online retailers offer a small charitable donation on purchases made using easyfundraising. These donations are small, but they add up, so far generating more than £4,000 for the Development Fund so far.

To get started, you can sign up by googling "easyfundraising" or via:

You then need to make sure that whenever you make a purchase, you go through the easyfundraising app to get to the site that you wish to use. This works on computers, tablets and and phones.

If you do your food shopping online you can earn funds for the building project every time you do so, and companies which sell insurance, holidays and clothes will also contribute a little extra to the building project. Here are a few of the retailers signed up to easyfundraising:





























Cash boxes

When you put your trousers into the washing machine, what do you do with any loose change that falls out of the pockets? If you find a 50p piece down the back of the sofa, where do you put it?

Our little cash boxes provide the ideal place for odd coins!

Small change adds up. A few hundred pounds are raised for the building project most years by faithful people putting odd coins (and sometimes notes) into little cash boxes. You will find a supply of these boxes at the back of church.

Completed boxes can be put into the offering plate on a Sunday morning. Please remember to complete the Gift Aid form inside the box.

Legacies

It is useful for any adult – whether aged 25 or 105 – to write a will to determine what will happen to their assets in event of their death.

Regardless of your age, you might consider making a donation to the building project by providing for this in your will.

If you have already made a will and it provides for a gift to St Mildred's then you can choose to direct this gift to the Development Fund by leaving with the will a clearly written statement that you intend the gift to go into the Development Fund if it is still in existence at the time the will takes effect.



Have you got any unwanted "stuff" that you could sell on eBay? When goods are sold to benefit a named charity, eBay waive their selling fees.

Both new and used goods can be posted on eBay. To generate funds for the building project this way:

Go to https://www.ebay.co.uk and if not already registered, register as a user.

To make sure that sale proceeds that you wish to donate are sent directly to the church, log in to Ebay and then click on "My Ebay" at top right of the screen. Near the top of the screen you will see:

Click on "Account".

In the middle of the screen you will then see:

Select "Settings" Then for "Charity donation payment method" choose Paypal. You will be taken to your Paypal account to confirm and then you are ready to sell.

Go to "Sell" and "List an item". There is plenty of guidance on the site about how goods should be described and priced. Fill in details of the item you want to sell.

At the bottom of the "Complete your listing" page is a heading "CHARITY". Click "Edit" and then turn on "Donate for this listing". In the "Find your favourite charity" box, type "Mildred". Within the search results you should see (and select):

O THE PAROCHIAL CHURCH COUNCIL OF THE ECCLESIASTICAL PARISH OF ST MILDRED'S, LEE, DIOCESE OF SOUTHWARK

Then click the arrow to the right of "Percentage" to select the proportion of the proceeds that you wish to donate, which can be from 10% to 100%.

The easiest things to sell are branded goods which are new or unused, but pretty much anything can be listed. People sell all sorts of things on eBay, for example:

Clothes

Unused ink cartridges for printers no longer in use

Odd pieces from dinner services (which can be very valuable as people will buy to replace broken items)

Tools, gadgets and spare parts for appliances

Bikes/scooters and toys

Maybe you really have some "cash in your attic"? You can often get a very good idea of the value of things by seeing how similar items have sold on Ebay in the past. For specialist items, such as old stamp collections, you should get specialist advice before selling on Ebay/

Good selling!

Arts, crafts and cooking

If you are nifty with a needle, good at woodwork or you enjoy making jam or marmalade, could you consider creating items to sell at Christmas? Our 2022 "Christmas catalogue" enabled church members to benefit the building project while doing their Christmas shopping. Almost everything offered for sale was snapped up quickly.

We are planning another "Christmas catalogue" for 2023. This will work really well if things are ready well in advance of Christmas... so why not start thinking about making things over the summer? Anything tasty/arty/crafty would potentially be suitable.

Research and odd jobs

At any given time there are usually various tasks that need doing on specific aspects of the building project, ranging from clearing weeds to re-formatting spreadsheets. Sometimes we need to dig out relevant information or research specific points. This usually requires nothing more than basic internet searching skills.

Matched funding

Many companies have schemes offering small amounts of matched funding to charitable projects in which their employees are involved. Barclays, for example, has offered its employees the opportunity to match funds they raise for their chosen charity up to £750 in one year.

The rules of these schemes vary as between different organisations. Some employers match amounts donated by employees and others match amounts raised by projects in which employees participate in some way. If you are in paid work it is worth checking whether your employer has any scheme of this sort.

If you work for any other organisation it would be useful to enquire whether they offer a charity matched funding scheme.

Donations

The main point of this booklet is to provide ideas about how to help with the building project at no additional cost.

However, we are very grateful to the many people who have donated money towards the building project and to all those who are committed to giving to the Development Fund on a regular basis. Without these funds, it would not be possible for us to continue with the project.

We understand that not everyone is in a position to give financially, but all gifts – however small – are much appreciated. Donations can be put in the offering plate at the back of church (clearly marked for the building project) or paid directly into the Development Fund:

We encourage any donor who is a UK tax payer to complete a Gift Aid declaration in order to allow us to recover basic rate tax on money donated. This can be done simply by sending an email to treasurer@stmildreds.org.uk stating "I confirm that I am a UK tax payer and that I intend all donations that I make to St Mildred's Church to qualify for Gift Aid."

A tithe of 10% is reserved from all gifts made to the Development Fund (and from any interest accrued and any tax relief payments). Grants received from public bodies and charitable trusts will not be tithed but will be applied 100% to the specific purposes for which they are given. Distribution of tithed funds will be at the PCC's discretion but with the expectation that the money will be

applied towards one or more suitable Christian mission projects requiring capital funding, such as building a new church overseas.
